

Heart2Heart Pet Lifeline Eligibility Guidelines

Coulee Region Humane Society assists Heart2Heart in determining whether eligibility guidelines are met. If guidelines are met, we will consider the application for a grant award. All funding requests for all domestic companion animals will be considered at Heart2Heart's discretion. We will NOT cover farm animals, animals owned by breeders, or animals used for research or commercial purposes of any kind.

The following criteria will be used to determine if funds will be awarded for an animal's care:

- The financial need of the animal owner.
- The opinion of the treating veterinarian as to the necessity and prognosis for the treatment needed.
- The urgent need for pet boarding services to prevent surrender of the animal.
- The demonstrated capability of the owner to take responsibility for his/her animal.

BASIC ELIGIBILITY GUIDELINES - PLEASE READ CAREFULLY!

- 1. All information is required. Only completed applications will be considered for funding.
- 2. The applicant must live within La Crosse County.
- 3. The applicant must be seeking assistance for necessary medical care, spay/neuter, emergency boarding services, or dog training.
- 4. Heart2Heart can assist unsheltered applicants needing to get their pet(s) vaccinated and licensing in order to access permanent housing. Please request further information from Coulee Region Humane Society or Heart2Heart prior to submitting an application.
- 5. Funding pledged will be available for 30 days after approval. Any cost beyond funding awarded or for services not covered by Heart2Heart is the responsibility of the pet owner to pay the business or veterinary clinic directly.
- 6. Heart2Heart grants are given directly to the veterinarian or business once services are provided and an invoice is received by CRHS from the veterinarian or business. Funds are never given directly to the grant recipient.
- 7. The applicant must have investigated other financial options and provide proof of financial need. Evidence of financial need can be demonstrated by participation in income-based programs or proof of low-income.
- 8. The applicant will be asked to provide us with a photo of his/her pet and must agree to allow us to include any, all or part of your story and a picture of your pet in our promotional materials. (We will not include your real name.)
- 9. A Heart2Heart board member may call to ask if the client is willing to participate in a media interview to tell their story and promote Heart2Heart services.
- 10. **Veterinary Services** grant decisions are based on several factors including: medical necessity, financial need, available funding and eligibility. A copay of \$25 is required and maximum awarded for veterinary services is \$400.
- 11. **Boarding Services** the application must detail specific circumstances, boarding time, and estimated cost from boarding business. A copay of \$25 is required. Heart2Heart will cover, if needed, required immunizations for boarding but will not exceed the maximum amount awarded of \$400.
- 12. **Spay/Neuter** grants up to \$100 which may be used at any area veterinary clinic. No copay is required.
- 13. **Dog Training** grants are up to \$60, no copay require. Funds are released to the trainer once proof of training registration and remaining cost of training paid by the applicant are provided to CRHS.

Heart2Heart does not cover the following:

- 1. Reimbursement for already completed treatment or help with an outstanding bill.
- 2. If you have already received assistance from Heart2Heart in the past 12 months.
- 3. Elective surgery (surgery not required for health).
- 4. If a pet is determined to be terminally ill it does not cover treatment beyond a vet visit to determine diagnosis.
- 5. Euthanasia and/or cremation fees are the responsibility of the pet owner.
- 6. Routine care such as annual vet exams, vaccinations, routine tests/screens or dental cleanings.
